**WORKING AN OUTDOOR STATION**

Weather is a major concern as are a host of factors when one is working completely outdoors. Proper clothing and shelter will be your responsibility and PWA will provide a location at Tyler Park for your rig set up.

There are rest rooms but they require that you will have to walk to them over uneven terrain and in darkness. So a good flashlight will be absolutely required for using the rest rooms during evening hours. We suggest if this is your first Field Day, to discuss this with any member or board officer who has attended one in the past.

PWA has taken as many steps as possible to assure that each member who participates in Field Day will have a memorable and enjoyable time at Tyler Park. We understand there are issues we have no control over, such as weather or band conditions, but hope each participant comes out and tests their skills and levels of communication on this exceptional once a year event. We believe if you follow good safety guidelines we have provided Field Day 2016 will be an enjoyable and educational event.

*Please be aware that the ARRL Field Day event is an outdoor event extending 24 hours including day and night, adverse weather conditions, and possibility of injury due to any or all of the following perils. In the past, PWA members have experienced heat, cold rain, lightning, insects, animals, rough terrain and other outdoor experiences. We strongly recommend you prepare yourself and family for outdoor exposure during the Field Day activity.*

**If you are not familiar with or have not worked a Field Day event, please be advised of certain exposures which may confront participants. These include but are not limited to the following.**

- 1. Storm conditions including cold rain, hale, high wind, and/or lightning.**
- 2. Rough terrain due to irregular field conditions with unexpected depression or animal habitat.**
- 3. Antenna structures are temporary and jury-rigged; they can be dangerous if falling unexpectedly.**
- 4. Pathways are over uneven surfaces and difficult to navigate in the dark or when wet.**
- 5. Biting Insects and poisonous vegetation in the agricultural field.**
- 6. Over exposure to the sun and heat exhaustion, or the cold.**
- 7. Electrified AC power distribution and RF-energized antennas.**
- 8. Fuel-fired AC Generators.**
- 9. Entanglement in lines, rope, and tie-out cord.**
- 10. Physical exhaustion and inadequate sleep.**
